(As a measure of consistency between this 858B IC and the 856A IC enter triple-position codes 'Exx', 'Nxx', 'Sxx' and 'Xxx' where the

first byte is literal and the 'xx' represent any valid alpha-numeric value that completes the code as defined by the Supply Community).
