1. Symbols and Abbreviations.

1.1. An asterisk (*) indicates new or changed form since last edition date.

1.2. The following abbreviations are used for Unit of Requisition and Type of Construction:

1.3. The following abbreviations are used for the month portion of the item date:

JAN - January	APR - April	JUL - July	OCT - October
FEB - February	MAY - May	AUG - August	NOV - November

2. Availability of Forms.

2.1. Local Reproduction Authorized (LRA). Do not alter the design or size of an LRA form during the reproduction process.

2.2. Stocked and Issued (S&I). Form is stocked and issued by the Office of Primary Responsibility (OPR). User requests through the OPR.

3. **Electronic Forms (EF).** Forms designed as EF are available on the LAN in Pure Edge Information Management Tools. USTRANSCOM forms are located on USTRANSCOM Customer, Enterprise, and Public servers under the USTRANSCOM publications folder. All electronic forms have print-on-demand capability.

4. **Privacy Act (PA) Forms.** An "*" in front of the form number indicates the form contains the Privacy Act statement.

5. **Obsolete Forms.** When a USTRANSCOM form becomes obsolete, it is automatically downloaded from the LAN and the new one, if applicable, is uploaded. The LAN will always have the most current form uploaded.
