Liner Ocean Transportation Program
Stabilized Breakbulk/Dry Cargo and
Container Billing Rates

The liner ocean transportation program stabilized cargo billing rates establish the amount Defense Transportation System (DTS) shippers will be billed for the movement of breakbulk/dry and containerized cargo through the DTS. Application of these billing rates is restricted to cargo that moves on scheduled commercial ocean liner service and is either booked by the Military Surface Deployment and Distribution Command (SDDC) or through one of the SDDC's booking systems.

In rare cases, customers will be billed using a method other than stabilized billing rates. Supplemental charges may be applied to the published stabilized billing rates or costs plus fee charges may be used to recover extraordinary costs that were not built into the rate basis when the billing rates were originally developed. Such cases include shipments in the Northern Distribution Network, one-time-only shipments, multi-modal CONOPS and other unique customer requirements.

The billing rates are defined in terms of Measurement Tons (MTONs) and their application is based upon the commodity being moved. One MTON is equivalent to 40 cubic feet. A discussion of the various Cargo Commodity (CC) Codes and an explanation of the procedures used for their application are presented below.

Determination of the applicable stabilized cargo billing rate is based upon Traffic Area (TA) Code pair (defined below) associated with the seaports of embarkation and debarkation used for the cargo movement. The billing rates are symmetrical and are the same irrespective of the direction of the actual cargo movement (i.e., the billing rate for CONUS East Coast (01) to Northern Europe (17) is the same for Northern Europe (17) to the CONUS East Coast (01)).

Charges associated with container detention are not covered by these billing rates and will be billed separately.

Breakbulk/Dry cargo billing rates are all inclusive when door-to-door movement is offered by USC carrier, otherwise the cost of line haul will be additive.

Container billing rates are normally all inclusive and cover all costs associated with the door-to-door movement of a SEAVAN container from its inland point of origin to its final inland destination.

Breakbulk Cargo Commodity (CC) Code Definitions

<u>CC</u>	<u>Nomenclature</u>	<u>Description</u>
01	Reefer	Perishable cargo moving on a breakbulk vessel that must be kept under constant refrigeration. Includes both chill and freeze cargo. DTS customer billing is based on the MTON volume of the cargo moved.
02	Bulk	Loose cargo moving on a breakbulk vessel. Cargo is not packaged (e.g., grain, coal, etc.). DTS customer billing is based on the MTON volume of the cargo moved.
03	POV	Vehicular cargo moving on a breakbulk or roll-on/roll-off vessel where the vehicles are owned by individuals rather than by a government agency. DTS customer billing is based on the MTON volume of the vehicles moved.
04	Hazardous	Cargo moving on a breakbulk vessel that is composed of explosive projectiles, bombs, mines, hand grenades, inflammable liquids, radioactive waste, explosive powder, dynamite or any other hazardous commodity that requires specialized handling or stowage. DTS customer billing is based on the MTON volume of the cargo moved.
06	General	Cargo moving on a breakbulk vessel that does not fall into one of the other cargo commodity code defined categories of breakbulk cargo. DTS customer billing is based on the MTON volume of the cargo moved.
07	Cargo Carrying Trailers	Trailers, van type semi-trailers, or stake and platform type semi-trailers moving on a roll-on/roll-off vessel, whether full, partially loaded or empty. DTS customer billing is based on the external MTON volume of the trailers or semi-trailers moved.
08	Special	Wheeled and tracked vehicles, any cargo item weighing more than 10,000 pounds, and/or measuring more than 35 feet in any dimension; moving on a breakbulk or roll-on/roll-off vessel. DTS customer billing is based on the external MTON volume of the cargo moved.
09	Aircraft	Whole aircraft or aircraft fuselage assemblies (whether or not engines are installed) moving on a breakbulk or roll-on/roll-off vessel. Does not include spare parts, engines, aircraft repair supplies, or boxed aircraft. DTS customer billing is based on the overall MTON volume of the cargo moved.

| 11 | Reefer | Containerized perishable cargo that must be kept under constant refrigeration to prevent spoilage (includes both chill and freeze cargo). DTS customer billing is based on the internal MTON capacity of the container used to move the cargo. |
| 12 | Vehicles | Containerized vehicular cargo (includes flat racks used for moving vehicles). Applies to both government owned and privately owned vehicles. DTS customer billing is based on the overall MTON volume of the vehicle moved. |
| 13 | General | Containerized cargo that does not fall under the definition for Reefer or Vehicular. Includes containerized hazardous cargo. DTS customer billing is based on the internal MTON capacity of the container used to move the cargo. |

02	CONUS (Gulf Coast)	Gulf of Mexico ports on the West Coast of Florida and in the states of Alabama, Mississippi, Louisiana (excludes Mississippi River Ports north of New Orleans) and Texas
03	CONUS (California Coast)	Pacific Ocean ports in the state of California
04	CONUS (Northwest Coast)	Pacific Ocean ports in the states of Oregon and Washington - Pacific Ocean ports in Canada that lie south of 50 degrees North Latitude
05	Canada (Newfoundland)	Atlantic Ocean ports in Canada that lie south of 52 degrees North Latitude and east of 67 degrees West Longitude
06	Canada (Labrador)	Atlantic Ocean ports in Canada that lie north of 52 degrees North Latitude, south of 61 degrees North Latitude and east of 67 degrees West Longitude – Includes ports of Greenland (including Narsarssuak) that lie south of 61 degrees North Latitude
07	Canada (Pine Tree)	Arctic Ocean ports in Canada and Greenland that lie north of 61 degrees North Latitude and south of 75 degrees North Latitude

19	Mediterranean (West)	Atlantic Ocean ports of Portugal, Spain (south of Portugal), Morocco and the Canary Islands – Mediterranean Sea ports of Spain, France, Morocco, Algeria, Tunisia, Balearic Islands, Corsica, Sardinia, Malta, Sicily and the West Coast of Italy

42	Scandinavia	Atlantic Ocean, Arctic Ocean, North Sea and Baltic Sea ports of Denmark, Sweden, Norway and Finland

44	South America (West Coast)	Pacific Ocean ports of Columbia, Ecuador, Peru and Chile to Cape Horn – Includes Pacific Island possessions of South American countries
